

**ANNEXURE**

1. The Licence shall be non-transferable.
2. The number of workmen employed as contract labour in the establishment shall not on Any Day exceeds 38 (Thirty Eight only).
3. Except as provided in the rules the fees paid for the grant, or as the case may be, renewal of the licence shall be non-refundable.
4. The rates of wages payable to the workmen by the contractor shall not be less than the rates prescribed for the schedule of the employment under the Minimum Wages Act, 1948, where applicable and where the rule have been fixed by the agreement, settlement or award, not less than the rates fixed .
5. In case where the workmen employed by the contractor perform the same or similar kind of work as the workmen. Directly employed by the Principle Employer of the establishment, the wages rates, holiday, hours of work and other conditions of service of the workmen of the contractor shall be the same as applicable to the workmen directly employed by the Principle Employer of the establishment on the same or similar kind of work , provided that in the case of any disagreement with regard to the type of work the same shall be decided by the Dy. Chief Labour Commissioner (Central) whose decision shall be final.
6. In other cases the wages rates, holiday, hours of work and conditions of service of the workmen of the contractor shall be such as may be specified in this behalf by the Dy. Chief Labour Commissioner (Central).
7. In every establishment where 20 or more workmen are ordinarily employed as contract labour there shall be provided 2 rooms of reasonable dimensions for the use of their children under age of six years. One of such rooms would be used as a play room for the children and the other as bedroom for the children. For this purpose the contractor shall supply adequate number of toys and games in the play room and sufficient number of cots and bedding in the sleeping room. The standard of the construction and maintenance of the crèches may be such as may be specified in this behalf by the Dy. Chief Labour Commissioner (Central).
8. The licensee shall notify and change in the number of .[workmen or the conditions to the Licensing Officer.
9. A copy of the licence shall be displayed prominently at the premises where the contract work is being carried on.
10. The licence shall, with in the fifteen days of the commencement and completion of the each contract work submit a return to the Inspector appointed under section 28 of the act intimating the actual date of the commencement o r as the case may be completion of such contract work in Form -VI-A.
